- Deadline:** Southern Territory teams will be approved when the check is received between March 15, 2008 and April 15, 2008 – 5:00pm or entry has been guaranteed by your ASA Commissioner by e-mail stoney@houstonasa.org. If the tournament does not have the required 24 teams on April 15, 2007 the deadline will be extended to May 26, 2008 – 5:00 PM for any Gold team to enter the tournament per the ASA Code.
- Draw:** Monday June 9, 2008 at 7:00 PM at Collins Park Mud Building.
- Rosters** All teams will turn in the National Tournament Entry Form, ASA Official Waiver & Release of Liability & Indemnification form (Roster) provide by the National Office. Both documents must be sign by your Commissioner. These documents will be turned in prior to the Managers Meeting at the Host Hotel. Player ID will be checked at this time.

- Rules:** As per 2008 ASA Official Rules of Softball and ASA Code
- Balls:** Furnished by the tournament - Wilson 12 " A9031
- Pitching Distance** Per the ASA Code (43 feet)

- Uniforms:** As per 2008 ASA Code Note: Shoulder straps ties must be used on the shoulders, not across the back of the uniform. Chin straps required. Face guards will be required per the ASA Code.
- Time Limit:** 1 Hour and 30 Minute for all games.
- Run Rule:** 15 Runs after 2 ½ or 3 Innings
12 Runs After 3 ½ or 4 Innings
8 Runs after 4 ½ or 5 Innings
- Tie Breaker:** International tie-breaker will be used as per 2008 ASA Code
- Awards:** 1st – 6th Place Awards to Qualified Teams
- Team Info:** Providing a team informational packet is a great way to maximize your team's exposure to the college coaches who will be in attendance. We will send you by e-mail an excel spreadsheet to complete the 1st week of May. This is strictly voluntary, but highly encouraged.
